**AFFIDAVIT OF MICHAEL I. FISTEL, JR. IN SUPPORT OF AN AWARD
OF ATTORNEYS' FEES AND EXPENSES**

I, Michael I. Fistel, Jr., being duly sworn, depose and say:

1. I am a partner of the law firm Johnson Fistel, PLLP ("JF" or the "Firm"), and a member in good standing of the Georgia Bar. I submit this affidavit in support of an award of attorneys' fees and expenses incurred in connection with services rendered in the above-captioned action (the "Action").

2. JF served as Counsel to Plaintiff Aaron Offringa in the Action.

3. The information in this affidavit regarding JF's time and expenses is taken from time and expense reports and supporting documentation prepared and/or maintained by the Firm in the ordinary course of business. I am the attorney who

oversaw and/or conducted the day-to-day activities in the Action for the Firm, and I reviewed these reports (and backup documentation where necessary or appropriate) in connection with preparation of this Affidavit. The purpose of this review was to confirm both the accuracy of the entries as well as the necessity for, and reasonableness of, the time and expenses committed to the litigation. I believe that the time reflected in JF's lodestar calculation and the expenses for which payment is sought as set forth in this affidavit are reasonable in amount and were necessary for the effective and efficient prosecution and resolution of the Action.

4. After this review, the number of hours spent on the Action by the Firm from case inception through October 10, 2025 (the day the Parties executed the Stipulation and Agreement of Settlement, Compromise and Release) is 31 hours for a total lodestar of \$27,012.50, based on the Firm's current hourly rates. A breakdown of the lodestar from case inception through October 10, 2025 is as follows:

5. After the adjustments for *de minimus* timekeeper entries described above, the attorneys and paralegals at my firm dedicated 26.6 hours through February 21, 2025 (the day the parties reached an agreement in principle to settle the Action) to the investigation and prosecution of the Action. The lodestar value of the work through that date is \$22,185.50, based on the firm's current hourly rates that are the usual and customary rates charged for each individual in our cases. A breakdown of the firm's hours and lodestar from case inception through February 21, 2025 is as follows:

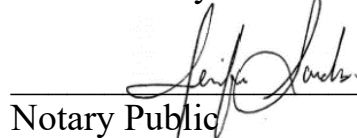
